Laboratory studies have shown Scotch™ Removable Magic™ Tape #811 removes cleanly from most common office materials such as sulphite bond paper, 25% cotton bond paper, yellow legal paper, manila folders, #16 note paper, and most office surfaces such as painted wallboard, wallpaper, finished woods, metals, plastics and upholstery at normal office temperatures and humidity for a period of up to one year. If minor adhesive shedding should occur, the adhesive can be removed by:

- 1. Wiping with dry tissue type product.
- 2. Low abrasion / soft rubber eraser
- 3. Window cleaner
- 4. Rubbing alcohol

Test removability before using. Avoid use in applications where clean removability from clay coated or specially treated papers is required. May not remove cleanly from some blueprint papers. May tear or pick fibers from loose bond papers such as newsprint, Kraft paper, and paper products not manufactured by the screen process.

This product is not suitable for packaging applications. Avoid applications on lacquered finishes, blackboards, CIBA chrome, and other photographic paper, LEXAN plastic and leather.
